TERMS AND CONDITIONS

- Each bidder will have to pay non refundable fee of Nu.500 (Ngulrum Five Hundred Only) to the Thromde Revenue Section in the form of cash on or before 29/07/2025 before 5.00 pm upon which a token card will be issued. Failure to produce the token card shall not be allowed to participate in the auction.
- 2. An earnest money of **Nu. 15,000.00** (Ngultrum Fifteen thousand) only in the form of cash will have to be deposited on spot to the Gelephu Thromde before the start of auction to qualify him/her.
- 3. The highest bidder, whose bids are accepted, will have to deposit a spot payment of 25% of the auctioned value at the fall of the hammer. The winning bidder withdrawing the bid or failing to deposit the amount as per terms and conditions will result in forfeiture of the security deposit (earnest money). The balanced amount should be deposited within 15 (Fifteen) days from the day of auction, failing which accepted bid will be cancelled and the earlier deposits forfeited.
- 4. The earnest money of the highest bidder will be retained until the auction is completed as security for subsequent bids to be offered by them in respect of remaining items. On completion of the auction, the earnest money of the highest bidder will be adjusted against the auction value of items won by them. The earnest money of unsuccessful bidders will be refunded immediately after completion of the auction.
