TERMS AND CONDITIONS

1. Each bidder will have to pay nonrefundable fee of Nu.500 (Ngultrum Five Hundred Only) to the Thromde Revenue Section in the form of cash on or before 18/12/2025 before 1.00 pm upon which a token card will be issued. Failure to produce the token card shall not be allowed to participate in the auction.
2. An earnest money of Nu. 15,000.00 (Ngultrum Fifteen thousand) only in the form of cash will have to be deposited on spot to the Gelephu Thromde before the start of auction to qualify him/her.
3. The highest bidder, whose bids are accepted, will have to deposit a spot payment of 25% of the auctioned value at the fall of the hammer. The winning bidder withdrawing the bid or failing to deposit the amount as per terms and conditions will result in forfeiture of the security deposit (earnest money). The balanced amount should be deposited within 15 (Fifteen) days from the day of auction, failing which accepted bid will be canceled and the earlier deposits forfeited.
4. The earnest money of unsuccessful bidders will be refunded immediately after completion of the auction.
5. The winning bidder shall remove all debris from the site with utmost care, ensuring that the existing concrete floor structure remains completely undamaged. Once the site is fully cleaned, it must be formally handed over to the Thromde Office for verification. Any damage caused to the concrete floor will lead to forfeiture of the earnest money. However, if the site is cleared satisfactorily and no damage is observed, the earnest money of Nu. 15,000.00 (Ngultrum Fifteen Thousand only) will be released.
6. The highest bidder whose bid will be accepted will have to take delivery of the item at their own cost within 21 (twenty one) days from the date of auction against full payment of the auctioned value. Failure to do so will result in the forfeiture of the deposit and the item being included in the next auction.
7. Safety of the workers and machinery engaged at site during dismantling and lifting is the sole responsibility of the bidder. Any cost incurred due to accident or injury shall not be entertained by Thromde.
8. The auction committee reserves the right to fix the starting price and reserve price prior to the start of the auction.
9. The auction committee reserves the right to accept the bid on the spot or at any subsequent date.
