6. Medical Certificate issued by a recognized Medical Authority within Bhutan, valid at least until the effective date of appointment (15th April 2026) (*Upload link: Medical Certificate*).
7. Any other relevant certificates, including certificates of excellence or extra-curricular activities (*Upload link: Certificates*).
